The **deadline for submission is April 28, 2014** (decisions will be communicated in May). Please include the authors' names and affiliations, the name of the prospective presenter, and the postal as well as the email addresses of the corresponding author. In case of acceptance, the **complete paper will be due June 10, 2014**.

Regardless of whether they present a paper, all participants are requested to act as a **commentator**.

Should you plan to participate at the conference without presenting a paper, please do not hesitate to register by writing an email to the local organizer, Sven Hoeppe (sven.hoppner@ugent.be), no later than **June 20, 2014**.

Travel and accommodation cost have to be borne by the participants. More detailed information on the registration procedure, the preliminary program, as well as accommodation and travel suggestions will be communicated from May on.

As in the previous years, the German Law and Economics Association might be able to reimburse a part of the expenses of younger researchers who do not have access to travel budgets at their universities.
